- i) first <u>and</u> last name;
- ii) initials, if any, used instead of a first name, or first and middle name, <u>and</u> last name;
- iii) nickname, if any, used instead of a first name, <u>and</u> last name; and
- iv) a derivative or diminutive name, if any, used instead of a first name, <u>and</u> last name:
