- o It was discussed as to the possible legalities on the bid process, it is determined by the County Atty, Schantz that the road repairs have been discussed for over a year and there were two companies that came in and wanted to do portions of the repairs and do rentals to the county but would never produce a bid in any form.
- o John Prince of Prince Inc; has looked at the project and produced a bid that is very fair.
 - The project entails 6.2 miles total and estimates about 1.5 miles of Repair/Replacement will be done/day.
 - **MOTION** Baue Moves to accept Resolution 2025-011 to have Prince Inc. do the repairs/replacement of 6.2 Miles to Pease Bottom Road, Baker 2nd, Motion Carries
- O Discussion/Update discussion on Gibson Road Bridge Project
